## **Old Business:**

- CC&R Amendment to the bylaws was presented by Peggy for clarification regarding solar panels, gutters & heat
  tapes. It will be clearly stated that the capital expense (installation) will be the homeowner's expense for those
  items. Maintenance will be the responsibility of the HOA for the gutters and heat tapes. The HOA will not be
  responsible for maintaining solar panels on any of the homes.
- Landscape Report: Peggy presented to the advisory landscape committee a purpose letter stating their responsibilities. Presentation of the landscape recommendations for 2021 was discussed in detail about many issues, including driveway dividers, patios, trees & trimming. Not all items were discussed dues to time, but it was the decision of the board to send out an email to all homeowners about landscaping recommendations and seek feedback and comments, then the BOD will decide how to move forward with remaining items. It was the decision of the board based on the budget to approve tree trimming, removal of 1 large cottonwood in island and 1 tree between 1264/1266, supplies for mulch, topsoil, grass seed and flowers. Chris motioned to approve, Gay second.
- Roof Repairs: Duncan has been out and completed work on units, he felt replacement wasn't necessary at this time. He feels the roofs will last a few more years.
- Painting Schedule: After reviewing the paint bids, it was the decision of the BOD to hire Mid Valley Painting. The 2 buildings that will be painted are 1278/1280 and 1262/1264. Peggy has all paint colors to choose from and will get those choices to homeowners. In additional to the buildings, Mid Valley will refinish/paint front doors of all homes that are in need and will walk the property to determine those to be done. All board of directors approved.
